

## Past Exalted Ruler's Scholarship

Six one time grants are awarded (3 boys and 3 girls) in the amount of \$1250 for the first place, \$1000 for second place, and \$800 for third place winners.

These are open to high school seniors. Applications may be copied, the application must be filled in completely, and the basic emphasis in judging will be on need, service, and leadership. Applications must be postmarked by February 15th, 2023.

### Qualifications:

1. *Open to any high school senior.*
2. *The application blank must be filled out completely with all blanks filled in. All other information must be attached to the application.*
3. *No restrictions on the type of school you will attend; I.e., may be Beauty School, Community College, Trade School, 2 or 4 year college.*
4. *The enclosed application blank will be the only forms judged. All previous forms are null and void.*
5. ***ALL INFORMATION SUBMITTED IN THIS APPLICATION IS SOLELY FOR THE USE OF THE NEBRASKA ELKS ASSOCIATION and will be destroyed after the scholarship process is complete.***

- 5) A list of your high school extracurricular activities (include number of seasons/years you participated and detail any leadership roles).
